



In February 2025, the National Coalition for Arts Standards (NCAS) [notified the field](#) of its intent to review national standards in dance, media arts, music, theatre, and visual arts. The 2025 National Arts Standards survey, conducted from February 18 to May 16, gathered nationwide feedback to determine whether the 2014 standards should be edited, revised, or discarded. Distributed broadly through NCAS member organizations, the survey received 3,490 responses and generated 5,632 comments across all arts disciplines and U.S. states and territories. Respondents rated their usage of, satisfaction with, and the impact of the standards on learning and teaching, as well as specific components such as the Conceptual Framework, Anchor Standards, and Artistic Processes.

Survey Results

Overall, the field expressed strong appreciation for the standards' structure, flexibility, and value for advocacy and reflective practice, while also calling for clearer articulation, reduced vagueness, and stronger support through professional development, exemplars, and supplemental materials. Common recommendations included better grade-band alignment, greater emphasis on discipline-specific skills, culture, global connections, careers, and updated guidance on technology and artificial intelligence. Collectively, the findings show a field that values the standards and signals a desire for refinement rather than a re-write.

Goals of the NCAS Review

Based on survey findings, NCAS has established five main goals for the review of these national standards with an overarching vision to address the evolving needs of the nation's students and ensure that the arts remain central to a well-rounded education.

The five goals of the review of National Arts Standards are:

- **Arts Learning for All**
Design standards with universal accessibility in mind so that students from all cultural backgrounds and all types of learners can benefit.
- **Concise Language**
Use clear, straightforward language so the standards are accessible, practical, and easy for educators to implement.
- **Student Voice & Choice**
Position students as active creators and decision-makers to foster motivation, agency, and deep artistic learning.
- **Technology & Artificial Intelligence (AI)**
Update the standards to reflect the growing role of digital tools and AI, integrating technical and artistic literacy.
- **Postsecondary Readiness**
Prepare students for college and careers by building artistic foundations and transferable skills such as creativity, collaboration, communication, problem-solving, and resilience.

In the coming months, NCAS will be recruiting a project manager to oversee the review process. The Project Manager will serve as the central coordinator for the National Arts Standards Review across all five arts disciplines—Dance, Media Arts, Music, Theatre, and Visual Arts. This leadership position will manage the complex, multi-year workflow, coordinating deadlines, communication, and documentation while ensuring the standards revision adheres to NCAS-approved processes. The role requires exceptional organizational skills and the ability to synchronize efforts among the Discipline Leads, NCAS Council, and review committees.
